## 4. Updates on NCPID 2025:

- o Dates: October 10-12, 2025.
- o Due to the IAP elections in October, only a subspecialty chapter conference will be jointly organized by IAP ID Karnataka and IAP Bangalore BPS.

Secretary : Dr Chetan Trivedi

- Venue: Tentatively at Hotel Four Seasons, Airport Road, Bangalore (three parallel halls, one dedicated to PGs).
- o Registration Fees:
  - (a) Rs.6000 for PGs (same fee throughout).
  - (b) Rs.6500 for IAP ID chapter members.
  - (c) Rs.8000 for non-PIDA IAP members.
  - (d) Rs.9000 for non-IAP members.

### 5. NCPID 2026 Bid Updates:

- o Seven bids were received from Guwahati, Bhubaneswar, Patna, Varanasi, Pune, Surat, and Noida (which later withdrew).
- o Presentations were made by representatives from six bidders:
  - (a) Dr.Gopabandhu (Bhubaneswar)
  - (b) Dr. Rashna Dass (Guwahati)
  - (c) Dr. Ashok Rai (Varanasi)
  - (d) Dr. Nigam Prakash Narain (Patna)
  - (e) Dr. Jayant Joshi (Pune)
  - (f) Dr. Digant Shastri (Surat)
- o Following discussions and Patna's withdrawal, the selection process was carried out via paper ballots, overseen by Drs. Raju Shah and Vijay Yewale.
- o Result: Pune won the bid for NCPID 2026 with a bid cheque of ?1,18,000 (including GST).
- o Dr. Vijay Yewale suggested offering opportunities for other bidders to organize national events or mid-term CMEs, and proposed holding one national academic event specifically for the North East Seven Sisters region every year or two.

  - (a) Update books on PID and infection control.
  - (b) Develop modules on non-responsive pediatric infectious diseases and emergencies.
  - (c) Launch an online hybrid course on pediatric infectious diseases, accredited by ICP or WSPID.

- (e) Plan to start online webinars with international speakers (twice monthly).
- (f) Issue membership numbers and certificates to all PIDA members.
- (g) Promote research activities, including consensus guidelines on SSTI, infection control best practices, and systematic reviews/meta-analyses.
- (h) Implement public health programs and celebrate national health days.
- (i) Create a committee for SOPs regarding conference bidding and organization.
- (j) Form a constitutional reform committee.

# 8. Financial Matters:

- Financial Report:
  - (a) The audited report was presented by Treasurer Dr. Yashwanth Rao and passed, pro posed by Dr. Raju Shah and seconded by Dr. Digant Shastri.
  - (b) The closure of the old account of the IAP ID chapter was advised.
  - (c) Membership fees should be deposited into a corpus fund, which may not be liable for GST (to be confirmed with the CA).
  - (d) Membership fees should be shown separately in the corpus fund every year.
  - (e) It was suggested to increase membership fees to ?2500 (inclusive of GST) from 1st January 2025, contingent on confirmation regarding GST applicability.
  - (f) Pediatric Infectious Diseass Academy wants to close the savings bank A/c No.1050741044 of "IAP ID Chapter" transfer the total amount to A/c. No. 3292179901 of "Pediatric Infectious Diseases Academy".

# Any Other Business with Permission of the Chair:

- Discussion on CIAP email regarding the draft MOU between IAP and subspecialty chapters:
  - (a) Dr.Daruru (Chairperson) briefed the house on some points in the draft received by **PIDA** to be discussed elaborately in EB:
    - 50% of subspecialty membership fees (or ?1000) to be given to IAP.
    - Merging of all subspecialty chapter conferences with IAP zonal or major confer
  - (b) The house strongly objected and decided to react once the MOU it is presented to the chapter for signing.Dr Daruru Ranganath suggested to discuss the issue at Hyderabad EB Meeting once the actual draft comes before replying CIAP.
